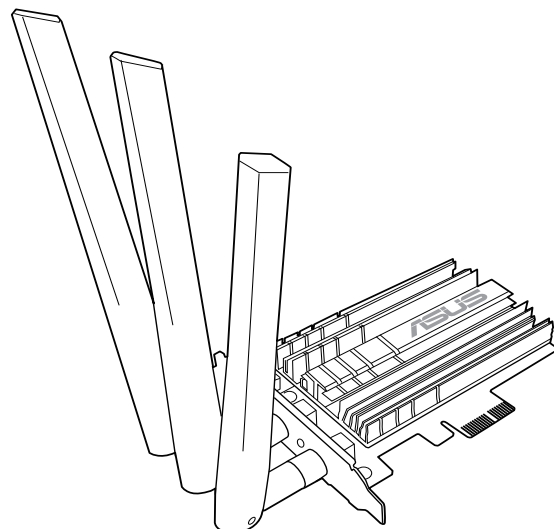


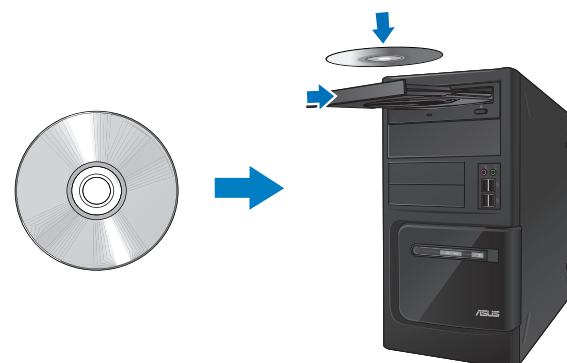

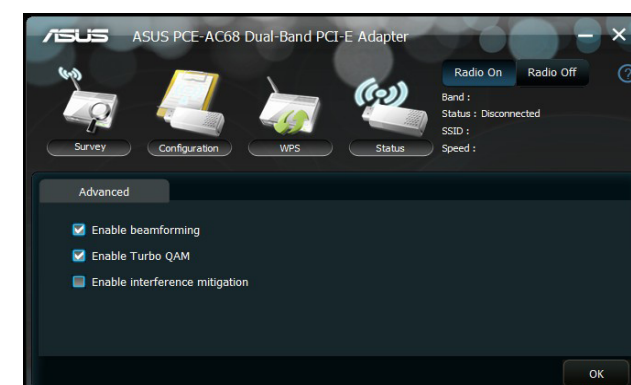


When the setup is complete, connect your desktop PC to the Internet wirelessly via PCE-AC68.

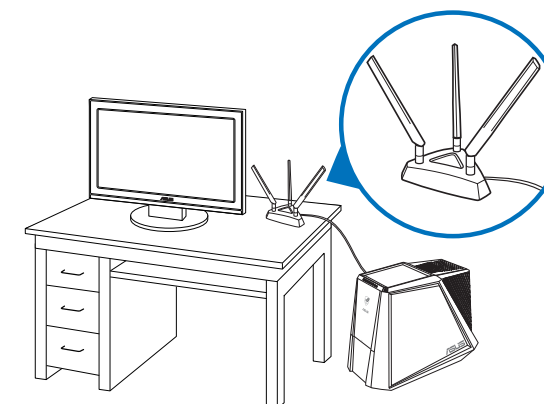
Setting up a Home Network
